WE ENABLE FAMILIES TO ACHIEVE, PRESERVE, AND SUSTAIN THEIR DREAM OF HOMEOWNERSHIP BY OFFERING FREE AND LOW-COST HOUSING COUNSELING, FINANCIAL EDUCATION, AND PURCHASE ASSISTANCE TO HOMEOWNERS IN WYANDOTTE COUNTY. DURING 2023, 295 CUSTOMERS WERE COUNSELED AND/OR EDUCATED AND 130 FAMILIES ACHIEVED OR SUSTAINED HOMEOWNERSHIP.

MINOR HOME REPAIR ASSISTANCE GRANTS WERE PROVIDED TO 24 AREA HOMEOWNERS.
